Conduct the "Final Hearing" regarding a Community Development Block Grant (CDBG) Competitive application in the amount of \$1,000,000.00 to the Pennsylvania Department of Community and Economic Development (DCED) to construct a public collection system and a surface water treatment plant in the Village of Oakland Mills as requested by the Fayette Township Board of Supervisors.
 - 2. Approve Resolution 2019-3 authorizing the submission of an application to the Pennsylvania Department of Community and Economic Development for Federal Fiscal Year 2019 under the Community Development Block Grant Program and further certifying compliance with the requirements of said program.
 - 3. Acknowledge the resignation of Heather L. Heckert as a caseworker with the Juniata County Domestic Relations Section effective at the end of business on June 5, 2019.
 - 4. Approve the "Purchase of Service Agreement" between Juniata County Children and Youth Services and Mifflin-Juniata Human Services for the implementation of the Juniata County Communities that Care Grant through the Juniata County Prevention Board. The term of the agreement is July 1, 2019 through June 30, 2020 with a fee not to exceed an annual rate of \$50,934.00.
 - 5. Approve the "Purchase of Service Agreement" between Juniata County Human Services and Melissa Fausey for the implementation and coordination of the Juniata County Prevention programming through the Juniata County Prevention Board. The term of the agreement is July 1, 2019 through June 30, 2020 with a fee not to exceed an annual rate of \$34,725.00.
 - 6. Approve the "Medical Assistance Transportation Program (MATP) Participation Grant Agreement" and "Assurance of Compliance". The Agreement shall commence on July 1, 2019 and terminate on June 30, 2020.
 - 7. Approve the 3rd Quarter Medical Assistance Transportation Program (MATP) Certification Statement for the period of January 1, 2019 through March 31, 2019.
 - 8. Approve the "Addendum to the Contract" between Juniata County Children and Youth Services and George Junior Republic, Preventative Aftercare, Inc. The term of the addendum agreement is July 1, 2019 through June 30, 2020.
