1. Approve the revised "ACH Origination Agreement" with the Juniata Valley Bank to increase the total aggregate ACH credit limit to \$75,000.00.
  2. Ratify "Amendment 1 to the Subgrantee Agreement" for Federal Fiscal Year 2015 by and between Juniata County and Richfield Area Joint Authority. The amendment is necessary to increase the CDBG Program funds by \$3,246.12, changing the original allocation from \$49,681.00 to \$52,927.12 and to extend the termination date from March 27, 2019 to August 30, 2019.
  3. Ratify the "Intergovernmental Agreement between Juniata County, Juniata County Probation, and the Juniata County Domestic Relations Section. The term of the agreement is July 1, 2019 through September 30, 2020.
  4. Approve the "Federal Fiscal Year 2018 Professional and Administrative Services Agreement" between Juniata County and SEDA-COG as submitted by Heather Kelly-Weisen, SEDA-COG Program Coordinator.
  5. Approve renewing the agreement between Juniata County and Mifflin County for the housing of Juniata County inmates. The term of the agreement is for January 1, 2020 through December 31, 2023 with the option of an annual renewal for up to three (3) additional years.
