

June 29, 2021

The Juniata County Commissioners met on the above date with Commissioners Alice Gray, Todd Graybill, and Mark Partner present. Also attending were Juniata Sentinel Editor Becky Lock, Community Development Director Bradley W. Kerstetter, and two unidentified members of the public.

The meeting was called to order at 10:00 a.m. by Chairperson Gray. A moment of silence was observed followed by the Pledge of Allegiance. On a motion by Partner and a second by Graybill, the Minutes of the June 22, 2021 meeting were unanimously approved as submitted.

There being no public comment, the Commissioners took the following actions:

- It was moved by Graybill and seconded by Partner to approve a budget modification to the McAlisterville Area Joint Authority Spring Rehabilitation Project (Contract No. C000075966) as per the information presented during the June 22, 2021 Public Hearing. The motion was unanimously carried.

Commissioner Graybill made a motion to approve the June 22nd Salary Board minutes which was 2nd by Commissioner Partner. The motion carried 4/0.

Treasurer King made a motion to approve creating a full-time Deputy Director of Fiscal Management position within the Fiscal Department. The motion was 2nd by Commissioner Partner and the motion carried 4/0.

Mr. Trenn replaces Nikki J Rohrbaugh who resigned. Salary and benefits will be as per the current bargaining unit contract. The motion was 2nd by Commissioner Partner and the motion carried 4/0.
