The meeting was called to order at 10:00 a.m. by Chairperson Gray. Prior to conducting any business, Chairperson Gray announced that Commissioner Mark R. Partner would be absent. Following that announcement, a moment of silence was observed followed by the Pledge of Allegiance.
